- AAUW national membership dues are \$49. \$46 is tax deductible as a charitable contribution, and \$3 is not deductible because it supports the AAUW Action Funds Section 501(c)(4) Lobby Corps and get-out-the-vote activities.
- Student Affiliate dues are \$17 of which \$16 is tax deductible and \$1 is not deductible.
- AAUW National Life Membership is \$980 and is fully tax deductible.

Note: Branch/state portions of dues are not tax deductible unless your branch/state is classified under the Section 501(c)(3) charitable entity status directly with the Internal Revenue Service.

Explanation of Terms



Full-year dues:

The ÅAUW branch membership year runs on a fiscal year basis from July 1 of this year through June 30 of next year. Collect between March 16 and December 31 of this year. The membership expires June 30 of next year.

Half-year dues:

Available only to <u>new members</u>. Collect between January I and March 15 of the current fiscal year. The membership expires June 30 of that year.

Transfer:

A member a) leaving one branch to join another, or

b) a national member (member-at-large) who decides to join a branch are both **transfer** members, <u>not</u> new members, unless they just recently joined. If expire year is this calendar year, national dues are \$49. If expire year is the next calendar year or later, national dues are \$0.

College/University Representative:

A faculty or staff named by the AAUW college/university partner member to serve as the liaison between the school and AAUW. This person may not be the same person who holds the position of college/university relations officer in your branch. Please make this clarification.

Dual Member:

A member of multiple branches holds dual membership. The branch that collects national dues is considered the primary branch. Any additional branch memberships are considered the dual branches and only collect the branch and state dues from the member. State dues should only be collected once a year per state.

Recruitment Campaigns:

Branch recruitment campaigns such as Shape the Future and half-year dues are for <u>new members only</u>. A new member is someone entirely new to AAUW or lapsed for two years or more. National members (formerly MALs) are not new members to AAUW but "transfers" when they join a branch. E-mail connect@aauw.org or call 800/326-2289 to verify the status of any former/national member.

Membership Year:

The membership year runs July I of this year through June 30 of next year for branches and college/university partners. National members (formerly MALs) run one year from their anniversary.
