

# AAUW National Dues, Fees, and Tax Deductibility

<p><b>National Membership</b> Individuals holding an associate or higher degree from a higher education institution accredited by a regional accrediting agency recognized by the U.S. Department of Education pay yearly dues of \$59. <b>Branch members</b> are also national members and may be required to pay local branch and state dues in addition to the national dues.</p>	\$59	\$56	\$3
<p><b>Paid Life Membership</b> Individuals who qualify for national membership may pay 20 times the <a href="#">national rate one time</a> and become exempt from further national dues.</p>	\$1,180	\$1,180	\$0
<p><b>Honorary Life Membership</b> Individuals who qualify for national membership and have been members for 50 years can <a href="#">apply for honorary life membership</a> and become exempt from further national dues.</p>	\$0	\$0	\$0
<b>College/University (C/U) Memberships and Students</b>			
<p><b>C/U Membership</b> Any accredited higher education institution is eligible to become a <a href="#">C/U member</a> and can appoint one or two eligible <a href="#">representatives</a> to receive free national membership. Local branch and state membership dues are an additional cost.</p>	\$175	\$175	\$0
<p><b>Memberships for Students of Non-AAUW C/U Members</b> Undergraduates or degree-seeking graduates enrolled in full-time or part-time programs may join and renew at this rate through graduation.</p>	\$18.81	\$16.81	\$2
<p><b>Memberships for Students of AAUW C/U Members</b> Undergraduates or degree-seeking graduates enrolled in full-time or part-time programs may join and renew <a href="#">at no cost</a> with automatic renewal through graduation.</p>	\$0	\$0	\$0
<b>New Member Campaigns</b>			
<p><b>Shape the Future</b> Members may offer <a href="#">50 percent off national dues</a> for new members who join AAUW at a public event.</p>	\$29.50	\$26.50	\$3
<p><b>Give a Grad a Gift</b> AAUW members may <a href="#">gift one year of AAUW national membership</a> to a recent college graduate at no cost to anyone.</p>	\$0	\$0	\$0
<b>Tax Deductibility Statement for Websites and Forms</b>			

- AAUW national membership dues are \$59, of which \$56 is tax deductible as a charitable contribution. The remaining \$3 is not tax deductible because it supports the AAUW Action Fund's section 501(c)(4) Capitol Hill Lobby Corps and get-out-the-vote activities. Student dues are \$18.81, of which \$16.81 is tax deductible and \$2 is not.
- AAUW national life membership is \$1,180 and is fully tax deductible.
